

Terms and Conditions for AUTO YARD,LLC and The reseller program.

Auto Yard, LLC is a licensed vehicles Dealer, Auto Broker and World Wide Auto exporter.

Buyer agrees and acknowledges that buyer is purchasing from AUTO YARD, LLC and NOT COPART.

We advise to all, that the reseller program is not an ideal program for every person.

Why do we say that? What you are buying may have hidden and unknown defects or mechanical problems, or additional damages that are sometimes not visible or disclose on the pictures. And also all vehicles purchases may sometimes have a salvage title or be sold as parts only with no title, and could not be registered in your state, please refer to your state and DMV laws, rules, and regulations before purchasing.

Auto Yard, LLC is not responsible for the condition or roadworthiness of vehicles you purchase.

1 : Registration Process & Deposits

To obtain a bid number and password there is a cost of **\$195** registration fee plus a **\$400** Securities Deposit that is paid up front through the registration process.

THIS WILL ALLOW YOU TO BID ON A SINGLE VEHICLE UP TO A \$4000 BID MAXIMUM, IN THE EVENT YOU WANT TO BID MORE THAN YOU NEED TO INCREASE YOUR SECURITIES DEPOSIT TO 25% OF YOUR BID PRICE. (EX: YOU WANT TO BID \$6000 THAN YOUR DEPOSIT WILL BE \$1500). **If you want to bid on multiples vehicles please email us or call us 1 603 898 9702 for more info.**

The securities deposit will be refunded and the bidder number terminated, If a buyer decides to be removed from the Reseller Program, the deposit **will be returned in full** if no bids have been **renege**d on and the account is in **good standing** with **no fees due**. Please allow up to 7 days for **deposit to be returned**.

However, The registration fee is non refundable

2 : Security deposit and Relist Fee

In the event a buyer reneges on a vehicle, the buyer agrees to pay Auto Yard, LLC the relist fee of \$400 or 20% of sale price, whichever is greater. This fee will be taken from your Security Deposit paid, in advance, to Auto Yard, LLC. Buyer is also responsible for any and all collection costs, including attorney fees and court costs. Bidding privileges will be suspended until payment has been received. **Any buyer that reneges on a second vehicle will have his bidding privileges permanently revoked.**

3 : Bid Number & Password. Upon successfully registering through our website, you will receive a Copart Online Bidding Login ID ("Login"), and a password ("Password").

You are responsible for your Login id and maintaining the confidentiality of your Password. The Bidder should not give out their Bidder Number or Password TO ANYONE. Payments responsibilities remains with you for all bids placed and accepted by your bidder number. You agree to immediately notify Auto Yard, LLC of any unauthorized use of your Login or any other potential or actual breach of System security.

There are 3 ways that vehicles are bought through the reseller program.

A: on approval ; means that the owner has 48 hour to approve the highest bid or reject it.

B: on minimum bid . means that the seller of the vehicles has a minimum amount that they wants.

C: none of the above: means the highest bid will buy the vehicles.

Bidders have the option to personally inspect the vehicles the day before the auction for a \$50.00 one day visit pass, or hire someone to inspect it. **Email** us for more info.

The bidders are encouraged to **email** or call AUTO YARD, LLC for issues and/or question prior to bidding.

We are available to advise and assist you on your bidding .Please do not call copart.

4 : Payment methods. All payments are made through paypal , western union, money gram, or wire transfer.

5 : Winning bids. Full payments are due 24 hours after winning notification, you will be emailed an invoice.

6 : Late payment. There will be a \$100 late fee if payment not received within 24 hours. After 2 days from winning bid notification the vehicles will be relisted if not paid for. (please refer to section 2)

7 : storage fee. If we are to transport your vehicles there will be no storage fee. If you were to arrange transport for your vehicles please be aware than Copart charges \$20 a day storage from the 2 day after the vehicles is paid for.

8 : Transport services. Vehicles cannot be driven away from the Copart yards. Transportation for each vehicle must be made after purchase has been completed. **Transportation, or exportation services of bidder vehicles is not included with the purchase price of these vehicles.**

Internet Bid Fees

Copart offers bidding kiosks in the lobbies of all of its facilities. These kiosks can be used to place preliminary bids on vehicles located at that particular yard. If a winning bid was placed on a vehicle using a kiosk located at that yard, no internet fees are assessed against that vehicle. If the winning high bid was placed during Preliminary Bidding via the internet, Copart

charges a convenience fee to the high bidder. The fee is based upon the high bid amount: a fee of \$35.00 for sale prices from \$1.00 up to \$999.99, a fee of \$50.00 for sale prices from \$1,000.00-\$1,999.99, a fee of \$75.00 for sale prices of \$2,000.00 or higher. If the winning high bid was placed during the live Virtual Auction, then the fee is \$35.00 regardless of sale price.

Gate Fee

A \$30.00 Gate/Loading fee is assessed to all vehicles. This fee covers the movement of the vehicle from Copart's sale/storage facilities to the buyer's loading area. For buyers whom are picking up the vehicle up with vehicle transporters, this fee covers the time and manpower required to assist the driver in loading the vehicle onto the truck. Drivers are 100% responsible for securing their load at all times.

Additional Fees (if applicable):

If a vehicle and all applicable fees are not completely paid within 3 business days of purchase including the sale day, a fee of \$50.00 per vehicles will be assessed. In addition, storage will begin to accrue on vehicles at the rate of \$20.00 per day after 7 days, including sale day, if the high bid was placed over the internet or after 3 days, including sale day, if the high bid was place during preliminary biding using a kiosk at the yard.
